

#### SCHEDULE 'C'

#### RULES AND REGULATIONS

of

### PUNE INTERNATIONAL CENTRE

#### 1. INTERPRETATIONS:-

In these Rules, unless the context otherwise requires:

- a) 'The Centre' means the Pune International Centre;
- b) 'The General Body' means the General Body of the Centre and shall consist of all the members on the roll;
- c) The 'Governing Council' means the Body of Trustees in which the powers of management of this Centre are vested.
- d) 'The President' means the President of the Governing Council of the Centre;
- e) 'The Vice President' means the Vice President of the Governing Council of the Centre;
- f) 'The Hon Treasurer' means the Hon. Treasurer of the Centre;
- g) 'The Hon. Gen. Secretary' means the Secretary of the Centre;
- h) 'A member' means a member admitted as such under these rules and whose name is duly entered in the membership register maintained by the Centre;
- i) 'Society' means Pune International Centre and duly registered under the provisions of Societies Registration Act, 1860, with the Assistant Registrar of Societies, Pune.
- j) 'Public Trust" means Pune International Centre and duly registered under the provisions of Maharashtra Public Trusts Act, 1950 with the office of Assistant Charity Commissioner, Pune.

- k) 'A Trust' is an obligation annexed to the ownership of the property and arising out of confidence reposed in and accepted by the owner, or declared as accepted by him, for the benefit of another or of another and the owner.
- l) "Trustee" means the person who accepts the confidence.

## 2. **JURISDICTION:** Shall be Pune.

#### 3. ELIGIBILITY FOR MEMBERSHIP

- a) Any person who is an adult and is interested in becoming a member and who submits an application in writing in the prescribed form for membership to the President/ Vice President/ Hon. Gen. Secretary/ Director and who agrees to pay the prescribed subscription/ annual fees and who agrees to abide by the Rules and Regulations of the Centre, shall be eligible to become a member of the Centre.
  - Provided that a full-time and salaried employee of the Centre shall not be eligible for membership of the Centre. Further provided that any honorary employee of the Centre, whether or not receiving any honorarium, shall be eligible for membership of the Centre.
- b) The Applicant for membership of the Centre shall become a member after his /her application has been approved and finalized by the Governing Council, and shall have the right to vote at the General Body Meeting of the Centre. Provided that the Honorary Members and Ex- Officio Members shall not have voting rights.
- c) The Centre reserves the right to make and enroll new members, and any membership application can be rejected by the Governing Council without giving any reason whatsoever.

#### 4. GENERAL:

i) The Centre/Society formed shall be irrevocable.

ii) The benefits of the Centre shall be open to all irrespective of the caste, creed or religion.

#### 5. CLASSES/ TYPES OF MEMBERS:

There shall be the following classes of members:

#### I. Individual Members:

- a) Founder Members
- b) Honorary Members
- c) Life Members
- d) Annual Members
- e) Professionals/ Youth/ Scholar Members. (also known as Associate Individual member)
- f) Ex-Officio Members

#### II. Organizational Members:

- a) Corporate Members
- b) Institutional Members
- c) Institutional Associate Members

#### 6. Qualification for Membership:

#### I. (a) Founder members

Founder Members are those persons who took an active interest or part in the establishment of the Centre and were enrolled as such prior to the Centre obtaining the Trust Registration Certificate under the provisions of the Maharashtra Public Trust Act, 1950, from the Assistant/ Deputy Charity Commissioner, Pune, and on payment of Rs.1,00,000/- (Rupees One lac only) as non-refundable admission fees. Provided that the Membership shall be given to the Individual concerned for life time and shall not be inheritable. Founder members shall have voting rights.



#### (b) Honorary Members:

Honorary Members are those persons either ex-officio or individual who have taken or are taking active interest in the objectives of the Trust and whose involvement is important to the Centre, and they may be chosen by the Governing Council for honorary membership. There shall be no admission fees or annual subscriptions for honorary membership. The Honorary Members shall have no voting right, but shall have right to attend and participate in all meetings of the General Body. The Honorary Membership will be conferred subject to the written consent of the respective person. Individual Honorary Membership shall be given to the Individual concerned for life time and shall not be inheritable.

#### (c) Life Members:

Life Members are persons of high attainment in education, science, culture, art, commerce, industry, agriculture or other areas of public activity. Presently the non-refundable admission fee to Life Members is Rs.1,00,000/- (Rupees One Lakh only) plus all applicable taxes. The Governing Council shall have the right to revise the admission fees from time to time and that will be applicable prospectively. Life members shall have voting rights. Membership shall be given to the Individual for life time and shall not be inheritable.

#### (d) Annual Members:

Annual members are persons in the fields of academia, art, culture, science, technology, sports or those engaged in public or professional functions and activities and are admitted by the Governing Council on payment of Rs.25,000/- (Twenty Five thousand

only) plus all applicable taxes per annum as admission fees. Membership Fees shall be non-refundable. Such Annual Members shall be entitled to all the facilities and privileges of the Centre, except the right to vote and participate in the meetings of the General Body. The Governing Council shall have right to revise the membership fee prospectively from time to time.



#### (e) Professionals/ Youth/ Scholar Members:

Professional/ Youth/ Scholar Members (also known as 'Associate Individual Members') are those who are admitted to the Pune International Centre essentially for a duration of less than 1 year at a time on payment of non-refundable fee of Rs.10,000/- (Rupees Ten Thousand only + all applicable taxes) per annum as membership fees, which shall be inclusive of annual subscription fees. The Governing Council shall have the right to prospectively revise the quantum of membership fee.

The membership of the Professionals/ Youth/ Scholar Members shall be renewable annually up to a maximum period of three years. Such Associate Members shall be entitled to all the facilities and privileges of the members of the Centre, except the right to vote and participate in the meetings of the General Body.

#### (f) Ex-Officio members:

The persons who are holding senior posts in the State or Central Government such as Hon'ble Chief Justice of India, Hon'ble Judges of the Supreme Court and the High Courts, Hon'ble Chief Minister, Chief of Army/Navy/Air-Force, Divisional Commissioner/Municipal Commissioner/Collector of Pune, Mayor of Pune,

Mayor of PCMC, etc. who are willing to have an exofficio membership of the Centre, the Governing Council may decide to give such membership to the interested persons. The Membership shall be valid till their tenure of service. The ex-officio members shall not be liable to pay any admission/ annual fees and they shall not have any voting rights. The Governing Council shall have the right to decide the eligibility criteria for ex-officio members and the number of ex-officio members to be granted such membership.

#### 6 (II)Organizational Members:-

#### a) Corporate Members:

Any organization which is a duly registered legal entity by nature and is working for profit and who applies for Corporate Membership in the prescribed format, to be enrolled as corporate member, shall be eligible to be enrolled as a corporate member. The said application should also mention the name of the representative who shall act as the representative of the said organization for all purposes in the working of the Centre. The application for Corporate membership shall be considered by the Governing Council and it shall be accepted or rejected by the Governing Council. The corporate member shall be required to pay the non-refundable admission fee plus applicable taxes and the annual subscription. The Governing Council shall have the right to prospectively revise the quantum of admission fee and the annual subscription. In the event of the Corporate Member desiring to change the nomination of its representative, the concerned Corporate Member shall submit a letter to that effect to the Hon. Gen. Secretary/Director of the Centre. The fee structure of the Corporate Membership shall be as follows:-

Institutions **such as** University, National Laboratory, Premier Institutions of research and higher learning, a Central Government Department, a State Government Department, or any other Society, Trust, Governmental Body or Authority, or any Association or Organization of persons interested in academic or cultural work, or any other public trust or charitable organization which is a non-profit organization may be considered for Institutional membership as per fees mentioned here under...

Admission fee:- Rs.1.00 Lakh Plus (Rupees one Lakh plus all applicable taxes). However, the Governing Council shall have the power to prospectively revise the quantum of the admission fee. Annual Subscription: Rs. 7500/- (Rs Seven Thousand Five

#### c) Associate Institutional Members:-

Any association or Organization devoted to academic or cultural work and registered as a Centre under the Societies Registration Act, 1860 or as a Trust under an appropriate Act, may be considered for Institutional Associate Membership as per fees applicable.

Provided always that no Association or Organization shall be eligible for admission as a member unless it has been set up under an Act of the Central or State Legislature, or a Resolution/ Order of the Central or State Government, or has been registered under the Societies Registration Act, 1860, or other appropriate Act or is a Limited Company in sympathy with the aims and objects of the Centre.

Provided further that any foreign University/ National Academy or Research Institution or any other Academic/ Cultural institution may be admitted as Associate Institutional member.

**Admission fee:-** Presently the non-refundable admission fees is Rs. 1,00,000 (Rupees One Lakh only) plus all taxes as are applicable from time to time. The quantum of admission fee shall be subject to any prospective revision that the Governing Council may decide.

Annual Subscription: Rs.7500/- (Rupees Seven Thousand Five Hundred only) p.a. (at present not applicable) subject to any prospective revision that the Governing Council may decide.

#### 6 (III) Cessation of Membership:-

Under the following reasons/ circumstances any member shall be disqualified and shall cease to be a member of the Society:

- a. Who is convicted of any criminal offence involving moral turpitude;
- b. Who tenders his/ her resignation and the said resignation shall be accepted in the meeting of Governing Council after which such person's membership shall be terminated.
- c. Who acts, contrary to the Rules and Regulations of the Society and acts adverse to the interest of the Society, the Governing Council may, with the majority of not less than 2/3<sup>rd</sup> of its total members, disqualify such member as; interest of Society.

However, before taking any action relating to disqualification of such a member by the Governing Council, an opportunity of hearing shall be given to the said member by the Governing Council and only thereafter, the Governing Council, if not convinced otherwise, can pass the necessary resolution about cessation/ disqualification of membership of such member.

- d. In case of failure to pay the membership fees for more than 180 days, payment of annual fees or any other dues shall be liable for cessation of his/ her membership. The Director shall submit such cases to the Governing Council for further disciplinary action, which may include cessation of membership.
- e. Any member of the Governing Council who remains absent for four consecutive meetings of the Governing Council (with or without leave of absence being granted) shall cease to be

a member of the Governing Council.

In case of demise of the member, his/her membership shall be ceased.



#### 7. PRIVILEGES OF MEMBERS:

a) Persons admitted as members under Rule (5) shall be entitled to all the facilities offered by the Centre. Provided that the voting rights shall be available to only Founder, Life, Institutional, Associate Institutional and Corporate Members.

#### 8. THE NUMBER OF MEMBERS:

The number of members in each class shall be such as may be determined by the Governing Council from time to time.

The admission fee shall be payable at the time of admission. The annual subscriptions towards membership shall be payable in advance for each financial year and shall be due for payment on the 1st April of each year. At present the annual subscription fee is Rs.7,500/- (Rupees Seven Thousand Five Hundred only) including taxes and the Governing Council shall have right to change this annual subscription fees from time to time. It shall be the responsibility of the members to ensure timely payment of the annual subscriptions and all other dues. Provided that the Honorary Members, Ex-Officio Members and Associate Individual Members shall not be required to pay any annual subscription.

## 9. MANNER OF FILLING IN VACANCY IN GOVERNING COUNCIL:

If any vacancy occurs in the Governing Council members/ trustees on account of disqualification of a trustee or on account of vacancy due to death or resignation of if a trustee

desires to be discharged or relieved from the trusteeship, then the continuing or surviving trustees shall appoint a new trustee in the vacancy caused by majority, from amongst the members. The person so appointed in the vacancy created shall work only for the remaining term of vacancy.

The following shall be the Authorities of the centre:-

- 1) The General Body
- 2) The Governing Council

#### 11. OFFICE BEARERS OF THE CENTRE:

The following shall be the Office bearers of the Centre:

- i. President
- ii. Vice-President
- iii. Hon. Gen. Secretary
- iv. Hon. Treasurer

#### 12. GENERAL BODY:

- 1) The General Body shall consist of all categories of members.
- 2) The General Body shall normally meet once in each calendar year preferably before 30<sup>th</sup> of September or more often, as per requirement.
- 3) The meeting of the General Body shall be presided over by the President or by the Vice President in the absence of the President or by a member elected by the General Body as the Presiding Officer if both President and Vice President are absent.
- 4) 21 members on record shall form a quorum at a meeting of the General Body.
- 5) If at a duly convened meeting of the General Body, there be no quorum at the time announced for the

meeting, the meeting shall be adjourned. The adjourned meeting shall be held after half an hour. For this re-convened meeting there is no necessity for a minimum quorum. However, the same agenda shall be considered at the adjourned meeting.

- 6) The Hon. Gen. Secretary on the instructions of the President shall convene the meeting of the General Body with at least 14 days clear notice. The notice of the meeting shall contain a specific agenda to be discussed at the meeting. The said notice shall be sent by any other method as per the choice of the Governing Council to all members.
- 7) The General Body at its Annual General meeting shall:-
- a) Consider and approve the Annual Report of the Centre as presented by the President.
- b) Consider and adopt the audited statement of accounts for the previous year.
- c) Consider the abstract of budget estimates of the Centre for the ensuing year.
- d) Consider the resolutions and amendments, referred to it by the Governing council or by the member of the Centre.
- e) Appoint Auditors and Legal Advisors for the following year.
- f) Review the events and activities of the Centre during the current Financial Year and take note of the upcoming events and activities of the Centre in the remainder of the current financial year.
- g) Deliberate upon any suggestions from the members in respect of activities of the Centre Transact such other business as may be brought forward with permission of the Chairman of the meeting.
- h) Note and confirm the decisions of Governing Council in respect of purchase/ sale/ mortgage/ lease of any immovable property and premises of the Centre.
- i) Elect a Governing Council for the tenure of 5 (five) years as and when the elections fall due.


8) All matters placed before the General Body for which no higher majority is prescribed, shall be decided by simple majority or show of hands, or by ballot, if demanded by any ten or more members present. In case of equality of votes, the Chairman of the meeting shall have a casting vote.

#### 13. GOVERNING COUNCIL:-

- 1. There shall be a Governing Council which shall consist of minimum 7 (seven) and maximum 25 (twenty-five) Members who shall be elected from amongst the Members of PIC. The Governing Council shall have the right to coopt Experts, from amongst the PIC members or non-members (including persons from the State/Central government or civic bodies), as non-voting Members of the Governing Council, if it is found necessary and convenient to do so in the interest of the Centre.
- 2. The tenure of the Governing Council shall be of 5 (Five) years from the date of assuming office. At least two weeks before expiry of the tenure, the new Governing Council shall be elected by the General Body in its meeting, which shall take charge after completion of tenure of previous Governing Council. Provided that the out-going Governing Council shall continue in office till new Governing council is elected as per the Rules and Regulations.
- 3. The members of the out-going Governing Council shall be eligible for contesting the election. No person shall be eligible to be a member of the Governing Council for more than three (3) consecutive terms of five (5) years each.
- 4. The Governing Council, in its first meeting, shall elect/select the four office bearers for the tenure of the Governing Council. Their designations are given hereunder.....

  - 2) Vice-President

13 A: The out-going Governing Council shall commence the election process at least two months before expiry of its tenure. The out-going Governing Council may appoint an independent Election Officer for conducting the elections, if so desired or may authorize the Hon. Gen. Secretary to conduct the elections. The Hon. - c. Date, time and venue for receipt of nominations, and for withdrawal of candidature.
- d. Date, time and venue for scrutiny of nomination papers and
- e. date for publishing the list of contesting candidates,
- f. date, time and venue for the polling and counting of votes and declaration of result of the elections.
- 2. The Governing Council shall prepare its internal Rules for conducting the elections, if required.
- 3. The elections shall be conducted by the independent Election Officer or by the Hon. Gen. Secretary, as the case may be, with the help and assistance of the Director and the Secretariat Staff of the Centre.
  - 3.1) After every 5 years  $1/3^{rd}$  members of the Governing Council shall retire.
  - 3.2) The outgoing Governing Council shall decide on methodology to be used for the retirement of 1/3rd of the Governing Council Members.

- 4. Any member who wants to contest the election, shall be required to submit his/ her nomination letter for contesting the election in the prescribed form and the said nomination form should be supported by at least two members viz a Proposer, and a Seconder, who must be any Individual member of the Centre having voting rights.
  - 4.1) Any Member who has not paid his/ her Membership Fees or Annual Subscription Fees within stipulated time, then he/ she can not contest the Elections of the Governing Council.
- 5. The notice for the elections shall be signed by the Election Officer and Hon. Gen. Secretary jointly. When no independent Election Officer is appointed by the Governing Council, then the notice shall be signed by the Hon. Gen. Secretary alone. Such notice shall be sent only to all members having voting rights, Fourteen (14) clear days before the scheduled date of the election.
  - 5.1) The notice for election shall mention the names of the members of the outgoing Governing Council who retire by rotation and the number of vacancies for which elections are proposed to be held.
- 6. After declaration of the results of the Election, the new Governing Council shall assume office on expiry of the tenure of the out-going Governing Council and hold its first meeting.

## 14. RIGHTS, POWERS AND DUTIES OF THE GOVERNING COUNCIL:

- All properties movable, immovable, or of any other kind shall stand vested in the Governing Council.
- b) The business and affairs of the Centre shall be carried on and managed by or in the name of the Governing Council.
- c) The Governing Council shall have all such powers and shall perform all such functions as may be necessary or

expedient for the achievement or furtherance of the objects of the Centre.

- d) The Governing Council shall have power to appoint committees and subcommittees for the purpose of various activities of the Trust. The appointed committees and subcommittees shall work as per the terms and conditions prescribed by the Governing Council. The Governing Council shall also have power to appoint outside expert members on the said committees if it is found necessary and expedient to do so in the interest of the Centre. The committees shall have powers to make recommendations in the form or reports, etc. and the same shall be placed before the Governing Council by the Hon. Gen. Secretary or Director for appropriate decision thereon.
- e) Without prejudice to the generality of the foregoing provisions, the Governing Council shall have the following rights, powers, duties and responsibilities.
  - To acquire by gift, purchase, exchange, lease or otherwise, lands, buildings or other immovable property together with all rights appertaining thereto.
  - ii. To construct and maintain buildings, including right to alter or to improve them and to equip them suitably.
  - iii. To manage the properties of the Centre.
  - iv. To accept the management of any trust fund or endowment in which the Centre is interested
  - v. To raise funds for the Centre by gift, donations, or otherwise.
  - vi. To raise loans as per requirement.
  - vii. To receive moneys, securities, instruments and/ or any other movable property for and on behalf of the Centre.
  - viii. To enter into agreement for and on behalf of the Centre.

- ix. To institute a funds/ scheme for the benefit of the employees of the Centre and manage such fund/ scheme.
- x. To grant receipts, to sign and execute instruments, and to endorse or discount cheques or other negotiable instruments through its accredited agents.
- xi. To maintain regular accounts & prepare Balance Sheet of each year and adopt the Budget for the ensuing year
- xii. To make suitable grants of moneys or other assistance to a university, educational institution or other Society, Trust for conducting any research or investigation or study in a subject in which the Centre is interested.
- xiii. To grant fellowship, scholarship or other monetary assistance, on such terms and conditions as it may decide, to such persons as it may select for the carrying on of any research, or investigation, or study in a subject in which the Centre is interested.
- xiv. To manage, sell, transfer or otherwise dispose of any property, movable or immovable, of the Centre.
- xv. To assign, from time to time, such functions and duties and delegate such powers as it may deem fit, to the committee.
- xvi. To lay down the powers, functions and duties of the Director, Controller of finance and accounts, Chief Librarian, Editor and such other officers as the Governing Council may appoint from time to time.
- xvii. To perform all such acts and do all such things as may be necessary for the proper management of the properties and the affairs of the Centre.
- xviii. To lay down the powers, functions and duties of the functionaries such as Director, the/ Hon. Treasurer and the Hon. Gen. Secretary

- f) The Governing Council shall have the powers appoint the Director (or such other designation), Chief Finance Officer. Chief Librarian, Editor and such other officers as it may deem fit on such terms and conditions of service as may be laid down by it from time to time.
- g) The Governing Council shall have powers to appoint any officer on honorary / contract basis and to fix the honorarium / fees payable to such appointees and to stipulate the terms and conditions of their appointments.
- h) The duties of the Director shall be as under...
  - i. To assist the President and other Office-bearers and arrange to assist any Committees or Sub-committees that may be appointed by the Governing Council in discharging their duties and perform such other duties as may be entrusted to him from time to time by the Governing Council.
- ii. He shall perform the duties of the Hon. Gen. Secretary in the absence of Hon. Gen. Secretary.
- iii. He shall arrange to send notices regarding meetings of the Governing Council / General Body / any Committees or Sub-committees that may be appointed by the Governing Council.

- The Governing Council shall have the power to make byelaws in respect of the following matters:
  - i. The management of the properties, funds, affairs and work of the Centre.

- ii. The conditions and procedure under, and according to which the elected members of the Governing Council and the Committee are to be elected.
- iii. The conditions and procedure under, and according to which the several classes of members of the Centre may be enrolled.
- iv. Decision on various categories of membership: The subscription including annual charges, if any, to be paid by the different classes of members subject to final approval of General Body.
- v. The rights, duties and privileges of the several classes of members.
- vi. The procedure for the election of members to the Governing Council/ committee, including, if it deems fit, for postal voting and voting by proxy.
- vii. The procedure for the convening and the conduct of the meetings of the Governing council, the committee, and such other bodies as may be set up from time to time including provision for the transaction of business by circulation of papers. Provided that till such time as the Governing Council frames bye-laws on any of the subjects mentioned here in above, the Governing Council shall carry out the respective activities and functions in respect of the subjects mentioned here in above by taking executive decisions.
- j) The Governing Council shall have the power to repeal, amend and modify the bye-laws subject to final permission of General Body.
- k) The Governing Council may, from time to time, delegate all or any of its powers to the Executive committee excluding powers pertaining to taking policy decisions pertaining the immovable properties, investment and borrowings of the Center and/ or the functionaries of the Centre.

- o) To organize and maintain, residential accommodation, with cultural and education amenities, for the members of the Centre coming to participate in the activities of the Centre and of other bodies with cognate objectives, as well as non-members specially invited to participate in the activities of the Centre.
- p) To invite, as and when feasible, thought leaders, scholars, scientists, creative artists and achievers in different walks of life, who may or may not be members of the Centre, to take advantage of the facilities offered by the Centre.
- q) To issue appeals and make applications for money and funds in furtherance of the said objects in the form of loans, deposits, donations, and subscriptions of cash and securities and of any property either movable or immovable.
- r) To invest and deal with funds and moneys of the Centre and to vary, alter or to transpose such investments from time to time.
- s) To purchase or otherwise acquire or take on lease or hire in the State of Maharashtra or outside, temporarily or permanently, any movable or immovable property necessary or convenient for the furtherance of the objects of the Centre.
- t) To construct, maintain, alter, improve or develop any buildings or works necessary or convenient for the purposes of the Centre.

## 15. PROVISION FOR BORROWING/ DEPOSITS AND INVESTMENT:

- 1) The Governing council may raise loans/ deposits, if necessary, on the security of the movable or immovable properties, and/or by mortgaging the properties of the Centre in consonance with section 36A(3) of the B.P.T. Act, 1950.
- 2) The Governing Council shall open, invest and operate all accounts of any description with any Nationalized, Multi National or private bank/s and to invest and deal with any money of the Centre not immediately required for any of its objects as provided under section 35 of the Bombay Public Trust Act, 1950.

# 16. PROVISION FOR PURCHASE AND SALE OF IMMOVABLE PROPERTY:

- The Governing Council shall acquire by gift, purchase, exchange, lease, hire or otherwise any lands, buildings, assets, rights of any property, movable and/ or immovable and any estate or interest for the Centre.
- 2) The Governing Council shall purchase, take on lease or otherwise acquire or to give its property on lease or hire as may be deemed necessary or convenient.
- 3) The Governing Council may sell, dispose, alienate, develop, transfer, off any property or any part thereof as may be considered necessary or convenient in the best interest of the Centre as per Section 36 of the B.P.T. Act, 1950.

#### 17. POWERS OF THE PRESIDENT:

The President shall exercise general control over the affairs of the Centre and shall give effect to the decisions of the Governing Council and in emergent cases, exercise all the powers vested in the Governing Council under clause 13 of the rules and regulations of the Centre and report the decisions taken at the next succeeding meeting of the Governing Council.



Provided that where any such action taken by the President affects any person in the service of the Centre, such personnel shall be entitled to prefer, within thirty days from the date on which s/he receives notice of such action, an appeal to the Governing Council.

#### 17A. DUTIES OF OFFICE BEARERS:

#### 1) PRESIDENT:-

- a. To preside, and chair the General Body meetings, and the meetings of the Governing Council as provided in the rules.
- b. To decide all matters/ issues by majority of votes.
- c. The right to call any meeting in case of urgency.
- d. To deliver casting vote in case of urgency.
- e. President is entitled to keep in hand an amount not exceeding Rs.25,000/- for day to day expenses.
- f. To assign the Director to perform the functions of the Hon. Gen. Secretary in his absence.
- g. To do all acts in order to promote the general welfare of the Centre.





- d) To present the budget to the Governing Council, for consideration and sanction.

#### 18. ADVISORY COUNCIL:

 a. The Governing Council may appoint an Advisory council to advice on the programmes and activities

- d) The meetings may be conducted through video conferencingin case meetings conducted by video conferencing, the members attending the meetings shall mark/provide their attendance by

- 9) To decide about raising funds by way of donations or loans or by any other mode;
- 10) To decide from time to time the quantum of Membership Fees for various types of members and annual subscription;

- 13) To decide date, time, venue and agenda for the Meetings of the General Body;
- 14) To frame bye-laws, rules and regulations of the Centre;

#### h) Quorum for meetings:

For meetings of the Governing Council, the quorum shall be  $1/3^{\rm rd}$  of the members. - a. The Centre shall have its own fund and all the receipts of the Centre through grants, donations, subscriptions and fees, as well as income from investments, publications and other sources shall be carried to the Fund and all payments by the Centre shall be made there from.
- b. All the incomes, earnings and movable and/ or immovable properties of the Centre when so ever and howsoever derived shall be applied solely towards the promotion of the aims and objects of the Centre as set forth in the Memorandum of Association. No portion of the income and property of the Centre shall be paid or transferred or distributed, directly or indirectly by way of dividends, interest or otherwise to any person(s) who at any time are or have been member(s) of the Centre or anyone through them, provided that nothing herein contained shall prevent the payment in good faith or honorarium, facilities of any nature, remuneration to any member, office bearer, officer or servant or anyone else, in return for services rendered. No member of the Centre shall have any personal claim on any movable and /or immovable properties of the Centre to make any profit whatsoever, by virtue of his/her membership.
- c. All expenditure paid out of the Fund shall be incurred solely for the promotion of the aims and objectives for which the Centre has been established, and in the manner approved by the Governing Council.
- d. The Centre may establish general, special or capital funds for furtherance of the aims and objectives of the Centre, and the money shall be deposited in Nationalized, Multi National and /or private banks or Public Securities.

#### 22. ACCOUNTS AND AUDIT:

#### 27. CHANGE IN RULES AND REGULATIONS:

A copy of proposed change(s) in Rules and Regulations shall be sent along with Notice to the members well in advance.

#### 28. LIFE OF MEMBERS:-

#### 29. INDEMNITY:

#### 30. SEAL:

If any amount is collected for some specific object, the said amount can be 100% spent for that object. Alternatively, such amounts can be spent on other objects as approved and decided by the governing council from time to time.

#### 32. DISSOLUTION:

If for any reasons it is decided to dissolve the Centre, the provision of Section 13 and 14 of the Societies Registration Act, 1860, shall be complied with.

In the event of dissolution the surplus assets/funds of the Centre as would remain after discharging all liabilities shall be transferred to any other Public Charitable Institution/Foundation having similar objects, and also registered u/s 12A of Income Tax Act, 1961, and the same shall not under any circumstances be distributed among the members.
